TITLE: "The benefits outweigh the risks?"

So much for informed consent (1). If you ask a recently Covid19 vaccinated individual "are you aware that the Covid19 vaccines can cause a fatal complication known as Antibody Dependent Enhancement (ADE)?" the most likely response will be "what is that?". ADE or pathogenic priming is a well documented and serious side effect of vaccines. ADE is a common problem with Dengue virus, Ebola virus, HIV, RSV and the Coronavirus family (2-4). ADE is problematic because it is a delayed reaction. Initially all seems well, the person seems to have a great immune response but then becomes deadly when the person is exposed to the virus again, months or years later.

If entire populations are immediately vaccinated with these experimental vaccines, the true incidence of ADE will never be known, as many cases will be falsely described as a "new variant" in the politically correct latin alphabet soup. Coronavirus vaccines have a long history of failure due to ADE. Following the SARS-Cov-1 outbreak in 2002 and after 10 years of clinical trials, vaccines were developed and trialled on ferrets, mice and cats, all vaccine candidates resulted in the death of many animals due to ADE and were not recommended to proceed to human trials (5-10). The current Covid19 vaccines were developed in about 7 months! Are based on new and unapproved vaccine technologies and rather than being extensively tested on animals they have been injected into about 3 billion humans.

ADE was described by Dr Robert Malone (co-founder of the mRNA technology used in the mRNA vaccines) as a "vaccinologists worst nightmare" (11). The American Front Line Doctors predict a potentially 20-30% death rate from ADE when vaccinated are exposed to Covid19 again (12). Nobel prize winning scientist Prof Luc Montaigner said epidemiologists "know" but are silent about the phenomenon known as ADE (13). Obviously, the globalist fact checkers and main stream media will dispute the risks and attack the messengers the same way they have disputed many things which have been proven to be true. Yet nobody has heard of ADE, health bureaucrats and investigative journalists have not mentioned this risk.

Of course ADE is well documented and this is a Global experiment of Biblical/Apocalyptic proportions where we are told to just "trust the science". But what about the new and unknown risks of the spike protein and nano-lipids

crossing the blood brain barrier? Even before the Covid19 vaccines were rolled out in the US, on 22 October 2020 a presentation by Steve Anderson from the Centre for Biologics Evaluation and Research to the Vaccines and Related Biological Products Advisory Committee presented a slide (14) with the possible list of adverse events from the Covid19 vaccines - see below.

Yet we are constantly being told, “the vaccines are safe”, the vaccines are already safe for pregnant and breast-feeding women, are safe for adolescents and soon will be safe for newborns, based on what evidence? The list of possible adverse events has never been properly discussed with the Australian public only suppressed and censored, the information presented in the US above corresponds to Covid19 related vaccine adverse events from government databases around the world. Dr Tess Lawrie’s urgent preliminary report on Covid19 vaccines Yellow Card UK government data - May 2021 (15) lists the following Adverse Drug Reactions (ADRs); Bleeding, Clotting and Ischaemic, Immune system, Pain, Neurological, loss of Sight, Smell, Hearing, Speech and Pregnancy adverse impacts. A look into the detail of these ADRs is extensive and shocking.

So finally, after 8 months of flooding the media with propaganda on the safety of the vaccines and scaring people into getting vaccinated with paid actors, stories missing critical details, coercing, blackmailing, ruining Australian businesses, forcing sole bread winners in families to take the experimental job or lose their livelihood and rocketing suicide rates the Therapeutic Goods

Administration released the adverse event report for the Covid19 vaccines (16). The TGA has dumped 75 pages of data into a format which is very difficult to understand and analyse and would take weeks to fully comprehend. However, with over 64,293 adverse events and nearly 564 deaths linked to Covid19 vaccines in about 9 months (17), the data corresponds with what was known by vaccine companies in October 2020 and Dr Tess Lawrie's report in May 2021. It is clear that not all reports are serious adverse events, but given the adverse events could be actually 10 times more than what is reported to the TGA (as has been indicated with the US - Vaccine Adverse Event Reporting System (VAERS) the information is very concerning. Also given that the number of Covid19 vaccine induced deaths in the UK for 8 months is 4 times higher than all vaccine induced deaths for 20 years (17), people are starting to wonder. Remember the days when life was worth something? In 1976 the US government suspended the national swine flu immunisation because of only 5 deaths! Today the VAERS has nearly 15,000 deaths from Covid19 vaccinations.

The benefits outweigh the risks! So far in Australia we have; 2588 cardiac disorders, 1619 vascular disorders, 33494 nervous system disorders, 8160 respiratory system disorders, 3162 eye and ear disorders (TGA report 16.08.21) and growing by the day. That is not to mention the gastrointestinal disorders, musculoskeletal and connective tissue disorders, skin and sub-cutaneous tissue disorders, infections and infestations, psychiatric disorders, reproductive system and breast disorders and immune system disorders and this is only the short-term data!

So what about the medium and long term data?

Many qualified international experts have speculated there could be cancers, neurodegeneration, prions diseases, multi-system inflammatory diseases, autoimmune diseases. And as this is a Global experiment underway, the data keeps coming in.

It seems like a huge human cost and given there are proven, safe and effective therapeutics available such as ivermectin and hydroxychloroquine which can treat all Covid19 variants in the luxury of one's own lounge room, this pandemic should have ended 18 months ago. Serious questions need to be asked now.

Firstly there must be an immediate halt to the Covid19 vaccine rollout and all people involved in pushing propaganda and concealing the truth should be investigated for "malfeasance". Australia right now is at a precipice.

Globally and in Australia, it is time to begin "Nuremberg 2".
