There is no question in my mind that our lives have changed since COVID-19

The areas where the greatest impacts will become evident include, for starters, the Economy & Markets, then Education, Race Relations, Entertainment, Technology, Environment, Sports, Diplomacy, Work, Politics (elections) and for us as Christians, religion and the church which is where I wish to delve deeper.


Prior to the COVID-19 pandemic, the religious landscape in Australia had already been undergoing considerable changes. Mainstream Christianity has been on the decline. Increasing Australians, and especially our youth, identify as spiritual but not religious and/or religiously non-affiliated atheists, agnostics or what has become known as the "nones" (Pew Research Center 2019).

exacerbate these changes, making it unlikely that some older people, who typically attend church, to continue to do so. Instead, many regular churchgoers are already turning to watch some people to realise they can practice their religion in other ways, through small virtual or in-person groups or simply by watching services virtually. Welcome to the world of the

'hybrid' church.

This will, and already has, most likely deepen the reluctance in 'giving' for many congregations with some denominations experienced diminishing contributions from congregants for decades. The prognosis must be that some churches will go under, others will merge, whilst some will continue on a part-time or limited basis. Just as the anxieties of the past have led many to search for greater meaning in their lives, the pandemic has at least made it easier for people to explore their spirituality,

with the move to online religious worship. As churches have long been a social

that persecute the church for opening its doors whilst sports, major events, and pubs are free to operate uninhibited.


The media is part of the transformation of Australia is undergoing. The media will also need to address the lack of true diversity in its ranks. The media today is predominantly pro-death, anti-Christian, and conservative averse. Amongst journalists, it is de rigueur to persecute anyone with a Christian worldview as evidenced by my own experience at FamilyVoice where we advocate for family, freedom, and faith.

As Christians we are fond of saying and emphasising the triumph of hope and life over fear. But how do people of faith observe one of the holiest days of the year if they cannot rejoice together on Christmas morning? I know of one Anglican church near me that is closing its doors on Christmas day – do you believe

How do Jews celebrate their deliverance from bondage when Passover Seders must take place on Zoom, with the elderly left to wonder why internet connection froze? Can Muslim families celebrate Ramadan if they cannot visit local mosques for Tarawih prayers or gather with loved ones to break the fast?

All faiths have dealt with the challenge of keeping faith alive under the adverse conditions of war, diaspora, or persecution—but never all faiths at the same time. Religion in the time of quarantine will challenge conceptions of what it means to minister and to fellowship. But it will also expand the opportunities for those who have no local congregation to sample sermons from afar.

There is no argument that the pandemic has altered the way many people come together to worship, and according to some church leaders, that change is here to stay. For me, as a novice social researcher, the practice of our faith under COVID will be forced to become more private, less community, less

The Year in Review

2021 has proven to be a year of unprecedented events. This president's report I'll reflect back over the year gone past and look at the highs and lows that shaped it. We have overcome many struggles and now is the time to plan for a more promising 2022. I have placed a number of bills forward that will be debated in the NSW Parliament in the New Year with the objective of keeping peoples liberties intact and maintaining a safe and prosperous economy.

JANUARY

1. 2021 New CDP Board Members

January kicked off with great promise as CDP announced its board members. As founder of the Christian Democratic Party it was a privilege once again to be elected to the position of State President. The other elected members were; Silvana Nile as State Deputy President, Mark Moody Basedow as State Prayer Convenor, Melody Ho as Youth Co-ordinator, Rev. Julie Collins as North Regional Country Representative, Pam Wise as Fundraising Officer, Edward Royal as State Treasurer, Tom Harris as State Secretary, Peter Arena as State Policy Officer, Lynda McGregor as State Membership Officer and Narelle Storey as South Regional Country Representative.

FEBRUARY

2. The Jewish Community Law Service

On 10th February 2021, I attended The Jewish Community Law Service at The Great Synagogue in Sydney.

This service has been conducted for over sixty years and takes place in the presence of the Chief Justice of New South Wales and State and Federal Judiciary. It marks the beginning of the legal year and is the Jewish community's tribute to the men and women who ensure that we are all governed by law, fairness and justice.

This year was visibly different as everyone wore masks as it was conducted in a Covid-safe way, in keeping with all Government advice and guidance. The turbulence of 2020 were also reflected in the opening remarks of The Hon. T F Bathurst AC Chief Justice of NSW: "It will be no surprise to anyone here when I say that the past year has been challenging, for our society, our communities and, of course, for our courts and the profession. We have all had to make many changes, to adapt our practice and to become more flexible than ever before. Meetings at places of worship became live-streamed services, video messages and online resources accessible from home when health demands required doors to be shut. Much of our justice system also transitioned into virtual courts or home offices."

MARCH

3. The Australian Population are showing growing concern of the COVID-19 Vaccines

Using data from the Melbourne Institute's fortnightly Taking the Pulse of the Nation (TTPN) survey, we have found that the willingness of Australians to get vaccinated has declined substantially from four months ago across all population subgroups.

The percentage of Australians willing to be vaccinated fell from 74.4 per cent in October 2020 to 66.2 per cent in February 2021, a drop of 8.2 percentage points.

This includes those who say they don't want to be vaccinated (vaccine refusers), the proportion of whom has increased from 12 per cent in October 2020 to 19.4 per cent in early February 2021. It also includes those who report being unsure (vaccine hesitancy), the proportion of whom increased from 13.6 per cent to 14.4 per cent.

APRIL

I was also given an award for my work in successfully having a motion



passed in the

NSW Parliament recognising the atrocity committed by the Ottoman Turks against the Greeks,

Armenian & Assyrian Christians during and after World War I.

The Federal Parliament is yet to take such action and the Joint Justice Initiative renewed its calls tonight. The event was also addressed by His Eminence, Archbishop of Australia Makarios.

More than 350,000 Greeks along with one million Armenians and Assyrians were killed in a systematic slaughter of men women and children. The Turkish Government, which succeeded the Ottomans, to this day refuses to acknowledge the genocide.

7. Honouring the death of Prince Phillip, The Duke of Edinburgh

I will always remember when Elaine and I met the Duke of Edinburgh on his visit to the NSW

JUNE

9. Rev Nile strongly opposed to cemetery merger Stands with Catholic Cemeteries Crematoria

The Christian Democratic Party commends Sydney's Catholic leaders in taking legal against the State Government over the recent decision to dismiss the Catholic Cemeteries Crematoria Trust (CMCT).

In a letter to the NSW State Government I signalled my opposition to the current plans to merge all NSW cemeteries a single State-Owned corporation, OneCrown. This action results in the effective dismissal of the CMCT who have been an extremely effective, efficient and respected industry operator for over 150 years. Rev Nile has stated 'CMCT has the experience and the history of respecting and aiding multi-faith communities with their funeral rites commending their loved ones to God'.

OneCrown, as a State-Owned corporation would not be entitled to the same Not-for-profit tax benefits that current operators utilize nor would it be eligible for a Perpetual Care Fund. Data obtained from the comprehensive 11th Hour Report has shown that funeral costs may rise up to \$9000 Rev Nile has stated "the massive increase in operating costs as a result of foregoing charitable status will be passed on to NSW taxpayers Ultimately the taxpayers of New South Wales are the losers of the current path who will have to bear the brunt of higher costs while mourning their loved ones.

The State Government has provided numerous assurances to multifaith leaders that they would be a part of the future solution for NSW cemeteries, why now is the Government breaking their assurances? Rev Nile further states that 'it is strange that a Coalition Government seeks to expand the role of government in matters of faith rather than respect existing operators in such a sensitive and important industry'.

10.NSW Government backs experimental gender treatment of children

The Christian Democratic Party is working on a bill, modelled on

similar laws passed in the United States, that would ban treatments on children that lead to chemical and surgical castration of them.

The CDP believes children who think they might have been born in the wrong body should be given love and support, not chemicals or surgery which can have life-long effects.

The Health Minister's full answer to my question are as follows: HEALTH AND MEDICAL RESEARCH—CHILDREN GENDER DYSPHORIA—Reverend the Hon. Fred Nile to ask the Minister for Mental Health, Regional Youth and Women representing the Minister for Health and Medical Research—

(1) Is the Minister aware that Stockholm's Astrid Lindgren Children's hospital in Sweden is ceasing the routine treatment of gender dysphoric children with puberty blocking drugs and cross sex hormones due to infertility and cancer concerns?

(2) Is the Minister aware that last week Australian gender clinicians from Westmead Hospital criticised the medicalisation of children's gender dysphoria?

(3) In both cases the Health Minster was asked by the media for a response to these developments and declined to comment. 5492 Legislative Council Questions and Answers No. 511—Wednesday 2 June 2021

(a) Why is the New South Wales government not speaking to the media about this important issue of child well-being?

Answer— (1-3)

I am aware of the matters being raised by the Member. Treatment and care of children and adolescents with gender dysphoria is a complex issue which must always be handled with the greatest level of care and sensitivity. NSW Health supports practice that is consistent with advice from the Royal Australasian College of Physicians (RACP) on care and treatment for children and adolescents with gender dysphoria. This care should be based on evidence and advice from medical and other health professionals with specific expertise, in consultation with the affected child or adolescent and their family.

11. The beginning of Greater Sydney lockdown

On June 25 The Greater Sydney lockdown including the Blue Mountains, Central Coast, Wollongong went into lockdown due to the new delta variant. The lockdowns did not lift in the LGA's of concern in Sydney till 11th October 2021

What started off with an initial lockdown of 2 weeks but on July 14 Premier Berejiklian stated "We need to extend the lockdown at least a further two weeks, from Friday the 16th to Friday the 30th with the current settings. That includes home learning, however we will obviously assess the situation at the end of those two weeks."

As the lockdown period extended so did the growth of the areas of concern and the reasons to leave your home became very limited.

Below are a list of reasonable excuses to leave home:

- 1. Obtain food or other goods and services (for your household or for vulnerable people)
- 2. Travel for work or education if it is not possible to do it at home (further restrictions now apply to residence living in Fairfield LGA or Sydneysiders working outside Greater Sydney area)
- 3. Exercise and take outdoor recreation in Greater Sydney.
- 4. Go out for medical or caring reasons.

JULY

12. Donegan family's baby to be recognised with Zoe's Law

I welcome media reporting last night that grieving mother Brodie Donegan's wish for her 32 week (8 months old) unborn baby's life to be recognised is to realised. After years of debate, lobbying and other efforts by myself, the Christian Democratic Party and many others, the Government is now reportedly adopting the core component of my bill Zoe's Law in their own legislation Offences Against Pregnant Women.

15. The Good Society & Government Complacency

Where is the moral leadership in our nation? The failure of Australian political leadership has resulted in the rapid erosion of the moral health of our society.

Five girls under the age of eighteen who have had double mastectomies because of LGBTIQA+ gender fluid ideology. It is currently legal for aborted babies born alive to be left to die. 17. State of Israel's 73rd Day of Independence celebrations

Silvana Nile did an exemplary job representing the Christian Democratic Party at the State of Israel's 73rd Day of Independence celebrations on 16th January 2021. The event was held at the Israeli Embassy in Canberra and the invitation came directly from Jonathan Peled Israel's interim ambassador to Australia.

The state of Israel declaration came into being on the 14th May 1948 the day the British Mandate expired. Jewish independence was restored after 3,000 years. At the establishment of the state there population count was 806,000 today the population of Israel numbers at 9,313,000.

Many have questioned the need for the existence of Israel, an argument voiced because of the ongoing conflict with Muslim Palestinians living in the West Bank and in the Gaza Strip. This is a question never asked of the 57 Islamic states that exist around the world. There is only one State that offers unconditional asylum and residency to Jews from all over the world that request it and that is 'Israel'. The question should really be, "Shouldn't there be a least one Jewish State in the world?"

Over Israel's 73 year existence many politicians, columnist and authors have said Israel is surrounded by enemies, it's torn apart by divisions inside it, it cannot survive. Yet despite its problems Israel does not only survive it flourishes because of the perseverance and the burning desire of its people to have a Zion sate a "national home". Israel counts as one of the most economically developed countries in the Middle East, it also has one of the most powerful armies in the region. In June 1967 Israel defeated three Arab armies (Egypt, Jordon and Syria) in just six days. The Arab-Israeli war radically changed the map of the Middle East, opening the way to occupation and settlement of Palestinian territories by Israel.

We congratulate Israel on achieving 73 years of Independence but the state's age does not do Israel true justice. Saying Israel is 73 is like saying that Egypt is only 99-years-old because it only gained independence in 1922 from the UK, or that Greece is only 199-years-old because the First Hellenic Republic was only founded in 1822, established during its war of independence against the Ottoman Empire.

The Jewish people's presence here goes back more than 3,000 years. Israelis got a reminder of that a few months ago when archaeologists announced the discovery of a fragment of the book of Zechariah dating back almost two millennia.

Peled stated "As we embark on Israel's 73rd year of independence, let us not forget the many challenges that still lie ahead, and the great achievements accomplished in such a short time. Above all we must not forget the great sacrifice of all those who made the dream and realisation of the Jewish State of Israel possible. Let us celebrate together. Chag Ha'atzmaut Sameach!"

AUGUST

18. THE KILL BILL - Assisted suicide legislation

Christians and Conservatives alike must never consider the stated intention of legislation alone but rather the trajectory of said legislation and where it will lead.

Member for Sydney Alex Greenwich has on a number of occasions announced his intention to put forward legislation that would in effect legalise euthanasia in NSW.

The Sydney Morning Herald reports that Mr Greenwich has made 'concessions' to the Christian and other faith based communities by providing exemptions in for faith based health providers the right to refuse euthanasia to their patients. It is a remarkable display of ignorance to suggest that the Christian community would support what Catholic Archbishop Dr Anthony Fisher has described as "state-sanctioned killing", a view that I personally agree with.

In Queensland their draft euthanasia legislation has broadened the parameters of who may apply to be killed to include those suffering from mental illness or disability. What could possibly go wrong?

And yet palliative care options are available, are funded and offer quality end of life healthcare. If Mr Greenwich and his supporters were truly sincere about offering healthcare they would throw their support behind palliative care rather than terminating the lives of our vulnerable.

Alex Greenwich's Voluntary Assisted Dying Bill 2021 makes the act of one person killing another legal in NSW, that is the simple fact of the matter. Canada has fully legalised Euthanasia since June 2016 (legal in

The COVID-19 pandemic has forever changed the political, economic and social landscape of the world forever. Where to Next?

We live in unprecedented times. Never, in the history of our country, have we seen lockdowns and border closures like we've seen in the past year. It's been devastating in so many ways. The COVID-19 pandemic has changed our nation.

Just think about what we've experienced during the past year. The handshake was banned, our state and international borders were closed, schools have been pupil free, the elderly have been in lockdown, sport was restricted, and churches have been closed.

But it's not just the pandemic that has been giving our leaders cause for concern. As non-essential services were forced to shut down and people were urged to stay at home, unemployment lines began to lengthen.

Thousands of people have found themselves unemployed or on government support payments and uncertain about the future. As governments scrambled to inject billions of dollars into their failing economies, the world collectively held its breath

In the midst of all this turmoil it is so easy to give way to despair. If this were an isolated crisis, something that maybe one or even two countries were facing, or even a single continent or region, it might not have hit us so hard.

But for the first time, in a very long time, this is a crisis that has touched every single part of the world, perhaps even more heavily than the World Wars of the last century.

Businesses are shutting down stores, laying off employees and some are even slipping into bankruptcy. All in the face of a single virus. Think about it. Our civilisation has been brought to its knees by a microscopic parasite ten thousand times smaller than a grain of salt. No one could have predicted that we would be faced with this kind of a global crisis two years ago, and yet here we are. There have been nearly three hundred million confirmed covid cases worldwide and over 5 million deaths.

As the infection rates climb and the death toll mounts, world leaders are facing a sickening choice; how many lives is the economy worth? It is a gruesome but necessary question that global leaders and economists are now asking.

As the cost of human life is weighed against the cost of an economic recession, experts are ready to remind us that an economic calamity can take lives too. Unemployment can lead to depression and despair. The political, economic and social landscape of our world has changed forever. And it's not over.

Quebec since 2015). The Canadian Government's own stats confirm that 21 589 Canadians have been killed since enactment in 2016. Based on annual reporting from the Canadian Government that figure has increased year on year

This should cause worry to Australians as Canada is very similar to us, we speak the same language, we are both constitutional monarchies, our legal systems are based on common law and our values are alike as well. Could thousands be killed in Australia if Euthanasia was legalised? Absolutely.

A particular disturbing part of this legislation is Division 5 – Written Declaration whereby a person who has allegedly requested to be euthanised may appoint another person to provide a written declaration on their behalf. Euthanasia is to be classified as a form of medical treatment. Rev Nile warns that "advocates for euthanasia could try to amend this current draft legislation to make it easier to kill patients under the pretence of medical treatment".

The Christian Democratic Party has been the crucial vote in defeating similar euthanasia legislation in 2017 and fully intends to vote NO again. We stand for life.

19. Malcolm Muggeridge on the Road to Damascus

The Festival of the Light rally in London's Trafalgar Square would gather thousands to demand reform at the growing trends in the mass media for the explicit depiction of sexual and violent themes and for

the restoration of conservative Christian morality in the UK. 50 Years ago on 25th September 1971 one of its founders Malcolm Muggeridge spoke at the festival.

Muggeridge, raised a socialist, had become an atheist and a Bolshevik, and one of the first newspaper correspondents to report from Moscow in the Thirties. He'd written books, worked as a gossip columnist and served in British intelligence during the second war. In the 1960's he became a convert to Jesus.

"I felt an abiding sense of being so in need of salvation myself,"

Muggeridge said, "that for me the Festival has been an immense clarification.... Man's true problem is his attempt to live without God, to live with fantasies that he's a God himself.... Without God, we are irretrievably lost in the darkness of mortality. Praise the Lord!"

This movement in Britain helped launch the Festival of Light in Australia on 10th October 1973.

In January 1974 my late wife Elaine and I were invited to be the full time Directors of the Australian Festival of Light organisation.

Intrigued about Muggeridge's conversion to Christianity I contacted him, in 1975 whilst he was living in the UK. He in turn invited me to visit him at his home in Suffolk Forrest U.K.

I spent a lovely time with Malcolm Muggeridge and his wife Kitty

at his home. During this time we discussed his faith and the incredible story of how he accepted Jesus Christ as his Saviour. \

He had been commissioned by the BBC to produce a documentary on the life of Jesus Christ, even though at that stage in his life he was a confirmed atheist. The BBC had intentionally employed him to create a satiric interpretation of the story of our Lord Jesus Christ but God had other plans for Muggeridge.

Filming the program started in Israel and it retraced the steps of Jesus Christ leading Muggeridge to Emmaus Rd in Damascus (Damascus today is the capital city of Syria). This was the very road the Apostle Paul took when he was breathing threats and murder against the disciples of the Lord. Because like Muggeridge, Paul at this stage had not accepted Jesus as the son of God. It was not until the risen Christ appeared to Paul on the road to Damascus that he became a believer.

When I asked Muggeridge what evangelist led him to Jesus Christ? He replied to me "Jesus Christ himself appeared to me. Jesus asked if I would accept him as my saviour". Just like in Paul's case only Jesus could stop him, only Jesus himself could convince him and only Jesus could save him.

In 1976 Muggeridge accepted my invitation to be a special guest at the Australian Festival of Light. We then embarked on a one month tour, visiting every capital city in Australia with the Festival of Light rallies, culminating in the largest rally at Hyde Park, Sydney where the attendance swelled to a sea of 35,000 people.

Muggeridge gives this message to the people at the rally "Fellow celebrants of the Festival of Light...I look around with pride and joy at all these faces, at all these banners, and this mighty turnout, and pray with all my heart that it may be the beginning of a the beginning of a continuing process

REPORT ON THE 22nd NATIONAL CONFERENCE OF AUSTRALIANS FOR CONSTITUTIONAL MONARCHY

The recent National Conference of Australians for Constitutional Monarchy, the 22nd since the referendum, was, on all accounts, a great success demonstrating how the organisation ACM remains steadfast in maintaining their values and beliefs, while resolutely campaigning against what ACM was first to identify as the 'politicians republic'.

Our Patron, 28th Prime Minister Tony Abbott describes ACM as the 'fiercest defenders' of the Constitution. This is demonstrated by our leading role at the Constitutional Convention, our long campaign to restore the Governor to Sydney's Government House, the landslide victory in the referendum, persuading the ABC to broadcast the Diamond Jubilee celebrations, our campaign to maintain the integrity of the referendum process and in calling the ARM to account over their broken promise to reveal their secret republican model.

Warm tributes were paid to Rev Nile who, because of an urgent commitment, could not attend. who served in the British Parachute Regiment and SAS as well as in the Australian Army,

- prominent lawyer, Jeffrey Phillips SC, who played a leading role in the referendum campaign (I well remember being with him in a debate against Malcolm Turnbull at the University of New South Wales), and
- prominent lawyer, John Armfield, who also campaigned in the referendum and who led the delegation arguing the case in the NSW Parliament for the retention of the Royal Coat of Arms in NSW courts.
- The proceedings were very much assisted by the active participation of two of ACM's Young Ambassadors, Will Jefferies & Daniel Lahood, who most effectively led the questioning.

Apart from the principal theme, a return to constitutional government, the Conference considered and strongly supported ACM's proposal for an Australian Medal to mark the Queen's

Platinum Jubilee, to be awarded only for selfless service. The designer of two magnificent Royal Coaches, Jim Frecklington, an ACM Patron, has been closely involved in design suggestions was present.

The Conference noted how ACM's determination to campaign on established principles and the latest technology, is paying dividends, with a recent Facebook post reaching over 200,000, a record. SEPTEMBER

20. A plea to the NSW Premier to advocate asylum for Afghan allies and Christians

We were all watching with great concern at the unravelling of

Afghanistan's fledgling democracy. The Taliban have seized power with unanticipated speed leaving our Afghan allies and Christians stranded in a country that has them ear marked for death.

On the 18th August 2021, I placed the following question to the Hon. Don Harwin MLC the Special Minister of State, and the Minister for the Public Service and Employee Relations, Aboriginal Affairs, and the Arts representing the Premier.

- (1) Senior Australian officials are talking with their American and British counterparts about possibly joining with those countries to rescue Afghans who have worked with Australian soldiers:
- a) Does the Premier know if the Prime Minister intends on also rescuing Afghan Christians at the same time, as they face imminent death from the Taliban?
- (2) The Christian communities of New South Wales are urging the Premier to speak to the Prime Minister about offering Afghan Christians asylum in Australia:

(a) Will the Premier advocate to the Prime Minister for these people to also be rescued and resettled in Australia?

The answer is due on 8 September 2021.

By 21 August the Australian Defence Force rescue mission had evacuated out of Kabul airport more than 240 Australian and New Zealand citizens, Afghan interpreters and contractors who assisted Australian troops during Australia's 20-year mission in the nation. The continued pressure from Christian leaders and communities, politicians and the general public had forced the Prime Minister to commit to allocating 3000 places within Australia's existing refugee program for people fleeing Afghanistan in the next 10 months, but said "we do believe we'll be able to do more than that."

On 26 August the evacuation mission ceased when two ISIS-K suicide bombers detonated explosive belts at the airport's gate.

Thirteen U.S. service members and at least 95 Afghans were killed and more than 100 Afghans were wounded in the blast.

The COVID-19 pandemic has forever changed the political, economic and social landscape of the world forever. Where to Next?

as we sometimes suspect, even on a whim.

When he was minister for health, Tony Abbott, drew up a plan to deal with future pandemics which attracted international praise. Sadly the Abbott plan is gathering dust somewhere in Canberra.

Where to next? The answer is to develop with widespread public participation and agreement a plan on how to deal with the next pandemic.

We cannot repeat the disastrous handling of the virus by career politicians who have little life experience, advised by medical bureaucrats, with that advice treated as if it were a state secret. We have seen political leaders behaving like dictators without any limitations on their power, with experts gagged, and modelling presented as infallible, neglecting expert Professor Box's famous warning: "All models are wrong, but some are useful."

The result has been that the wisdom in Lord Acton's timeless warning, that power tends to corrupt and absolute power corrupts absolutely, has been completely ignored, even by the largely compliant media, Alan Jones and few others excepted.

The plan must insist on a return to what was once normal practice in relation to the making of regulations. First, any such regulation must be submitted to the Executive Council where the governor-general or governor must be satisfied he has the power to do what is recommended and that any conditions have been fulfilled. If adopted, the regulations would be tabled in and both Houses of Parliament and subject always to their ultimate power of disallowance. This is a necessary Sword of Damocles over wayward ministers who have exercised power not in the public interest, but on poor advice, for political advantage and

The plan should call for some personal liability by ministers for misfeasance in public office, as found recently by the Federal Court in relation to the live cattle ban. Why should only the taxpayers pay? The plan should also ensure that politicians can never again attribute some good result, such as a comparative low death rate, to their excesses. The fact is that such benefits will normally flow from the geographical fact that we are a remote island nation. In relation to any virus, governments should be required to publish independent advice as to the protection gained by our geographic advantage. The plan should also set out very clearly the full extent of federal and state powers and their agreed roles, so that

there can be no obfuscation or evasions on these points.

The plan should contain what I believe is a core principle. This is that the first task of government is to bar entry of the disease into Australia, at least until an assessment can be made, indicating who is most vulnerable and how they should be to protected, while allowing the rest of society, as far as possible, to continue in its normal operations.

We should never again borrow a model from a communist dictatorship — the lockdown — all at enormous cost, massive debt and unjustified damage and suffering, particularly to small business, schoolchildren and quite wickedly, even to relatives of those near death. The plan should disincentivise recourse to lockdowns by a consequent drastic reduction in the relevant politicians' and bureaucrats' income.

Vaccination is a crucial issue. In Operation Warp Speed, President Trump demonstrated how vaccines can be produced in record time. Bearing in mind the known side-effects and that long-term consequences will always be unknown, the plan should incorporate another core principle, that recourse to such vaccines should be voluntary and primarily for the most vulnerable.

The plan should warn against interventions by powerful groups, such as social media, who may have other agendas. It should encourage measures to mitigate media hysteria by requiring full disclosure by government. For example, on the relative seriousness of cases, and in relation to deaths, as to the precise cause.

It is of crucial importance that plan extend to action to take concerning perceived misbehaviour by a foreign government. Beijing behaved appallingly by hiding the existence of the virus and allowing vast numbers of people to fly out of China and unknowingly spread the disease around the world. The damages to Australia is enormous. Why should Beijing escape responsibility for this? In a piece in *Spectator Australia*, 28.iv.2020, I argued that we should not go the compromised WHO as the Morrison government subsequently did. Instead, I argued that we should set up an international tribunal by a treaty with the then Trump-led US and other interested powers to apportion responsibility and award damages. Legislation could allow any damages awarded to be recouped against mainland investments under the control of Beijing in Australia.

The point surely is that we cannot afford to repeat the mismanagement and incompetence we have seen with respect to the Wuhan virus. We must have a plan with certain core principles and with the involvement and consent of the people.

21. NSW taxpayers funding child sex grooming website. Where is the Health Minister?

The Christian Democratic Party has recently been made aware of a State Government website created by NSW Health and funded by the taxpayer. This website is called 'Play Safe'. The stated purpose is to be a "one-stop shop for young people wanting to know about safe sex".

This website is specifically targeting young Australians on how to have safe vaginal, oral and heterosexual anal sex. Unfortunately, it is so much worse than that. The Play Safe website has a forum whereby users can post about topics and questions, this forum is monitored by NSW Health employees. Some of these topics include:

'How do you have anal sex for the first time?' – In this thread various taxpayer funded forum 'Moderators' ask each other how to have anal sex 'safely'. Anal Sex is not safe, it is the riskiest and most likely transmission of HIV and permanently damages the muscles around the anus.

'When should we start educating on consent?' – In this thread a 'Participant' (that is a member of the public) suggests teaching children as young as 10 about sexual intercourse.

'What's your favourite sex toy?' – A participant describes their favourite sex toys and forum moderators continue the conversation with their own favourite sex toys. Why are taxpayers funding this?

'Say goodbye to anal sex' – In this thread a participant expresses concern about having anal sex but the forum moderators provide advice on how to 'safely' have anal sex. The moderators link to a page on Play Safe that provides further instructions on how to perform anal sex

'SEXting', a participant asks about fellow forum users 'naughty' experiences with sexting. Various forum moderators share their stories and encourage the act of sexting. Young women are often exploited by manipulative partners after the sharing of sexual images. This is currently considered to be child pornography for those under the age of 18. Why is NSW Health promoting positive discussion of sexting when there are numerous campaigns, academic and Parliamentary

resources that warn of this practice?

There is also a Question & Answer webform administered by a 'Nurse Nettie' that claims to be a 'real, qualified sexual health nurse based in Sydney'. My researchers have contacted this hotline and found that this person is actually the NSW Health Statewide Sexual Health Hotline. This alias replied to a forum user concerned about anal sex and says:

"Anal sex is not new & it's an important part of millions of people's sex life. It's normal & healthy for those who enjoy it. If it's not for you, that's normal & healthy too. We all get to decide what kind of sex is right for us"

Does the NSW Health Minister concur with this medical advice? Who is 'Nurse Nettie'?

When a young person posted they were growing up and confused about their gender, the so called expert Nurse Nettie did not tell them to first seek help form their parents or a medical professional. They instead were steered to trans and gender diverse people who clearly have their own agenda.

The safety of young Australians is of key importance to the Christian Democratic Party. This website is hardly educational and is very similar to the controversial 'Safe Schools' program (which was terminated after public outcry). 'Safe Schools' was child abuse disguised as an 'anti bullying' programme, 'Play Safe' is child grooming disguised as a 'sexual health' website.

Again we collected thousands of signatures from members and supports on this matter. As a result the offensive Play Safe website posts were taken down immediately.

22. Democracy suspended - Workers forced to vaccinate -Our Public Health Amendment needed NOW!

In September the State Government announced that Construction Workers will be allowed to return to their worksites on the provision that they have vaccinated.

In effect this is mandatory vaccination by financial coercion. The Christian Democratic Party (CDP) is opposed to this anti-democratic practice.

Earlier this year I introduced the Public Health Amendment (Vaccination Compensation) Bill 2021.

The intention of this bill is to provide financial compensation to workers who are forced to vaccinate and suffer injury, loss or damage as a result.

Independent researcher Michael Kowalik in his research paper

Ethics of vaccine refusal states "mandatory vaccination amounts to discrimination against healthy, innate biological characteristics, which goes against the established ethical norms". Kowalik's view is that of our own, we are not opposed to vaccination but strongly support the agency of human beings to decide their own medical treatment.

Due to the lockdown the NSW Parliament is unable to sit, it has not been able to sit since late June 2021.

This means many things, but most importantly it means that your elected representatives are unable to introduce or pass legislation. In effect, a core and vital function of our democracy has been suspended without a clear return date. Meanwhile, the Attorney General has been awarded powers that allow him to determine regulations on any law that the Government desires.

This is a terrible legislative precedent.

As I have stated previously, no Australian worker should lose their job if they refuse this jab. There are many ethical, religious and medical reasons why they will not or cannot receive this jab. This basic human right must be honoured, protected and if violated then compensated.

I will be pushing ahead with my bill, for the sake of Australian workers, their families and our liberties.

WHY CAN'T YOU BE NICER, LIKE JESUS?

Just being 'nice' is not enough:

Anyone who stands up for biblical truth in this age of relativism, emotivism and political correctness knows full well that the critics will come out attacking you fast and furious. And here I have in mind the legion of Christian critics who will always jump on you, claiming you are not being loving, not being Christlike, not being nice.., etc.

I get these folks all the time. Now, are there Christians who are rather unloving, rude, crude and mean? Yes. But too often those of us who seek to defend biblical truth in the public arena are called all this and more by other believers who think that Christianity is all about being 'nice' and not offending anyone. I have already penned a number of pieces on this matter, eg.: billmuehlenberg. com/2014/04/08/no-more-mr-nice-guy/

But I still get the critics writing in, concerned about my 'tone' and the like. As if tone is all that matters. And as if none of the people we read about in the Bible ever had a strong and forceful tone! But the spirit of the age is so often what seems to drive these folks, not biblical truth.

I again recently had another person sharing his concerns with me about this matter. He thought I was being far too 'forceful' and asked what good I was accomplishing. He also asked if it was not 'better to love than to be right?' These are common criticisms that I get quite

often. In this case I replied to this guy as follows:

Thanks *****. But I prefer the biblical path which of course never pits love against truth. Both are vitally important and both must be pursued simultaneously. The most loving thing we can do is share truth, challenge lies and deception, and prevent those with false views from deceiving others, and heading to a lost eternity. And if you are opposed to "forceful" rebuttals of error, then you must think the prophets, Jesus and Paul, to name but a few, are all to be condemned. Consider a few "forceful" and very public words from Christ from just one gospel:

Matthew 12:34 You brood of vipers, how can you who are evil say anything good? For the mouth speaks what the heart is full of. Matthew 12:39 He answered, "A wicked and adulterous generation asks for a sign! But none will be given it except the sign of the prophet Jonah."

Matthew 15:7 You hypocrites!

Matthew 15:14 Leave them; they are blind guides. If the blind lead the blind, both will fall into a pit.

Matthew 15:16 "Are you still so dull?" Jesus asked them. Matthew 16:23 Jesus turned and said to Peter, "Get behind me, Satan! You are a stumbling block to me; you do not have in mind

the concerns of God, but merely human concerns." Matthew 17:17 "You unbelieving and perverse generation," Jesus replied,

Matthew 23:16 Woe to you, blind guides!

Matthew 23:19 You blind men!

Matthew 23:27 You hypocrites! You are like whitewashed tombs! Matthew 23:33 You snakes! You brood of vipers! How will you escape being condemned to hell?

But by your way of thinking, he was far too unloving and un-Christlike, and turned people off. Sorry, but I will side with Jesus here on this one! Truth matters, and not responding to error endangers the person holding to the error. There is nothing loving or Christian about just winking at error or ignoring it, all in the name of being 'nice'.

As I just read in 1 Timothy 2:24-26: "And the Lord's servant must not be quarrelsome but kind to everyone, able to teach, patiently enduring evil, correcting his opponents with gentleness. God may perhaps grant them repentance leading to a knowledge of the truth, and they may come to their senses and escape from the snare of the devil, after being captured by him to do his will." Paul got it right. And he could be VERY forceful in correcting others, mincing no words. But thanks for your thoughts.

Indeed, there are hundreds of such examples in Scripture of God's servants using very forceful and even at times derogatory and

harsh language as they oppose error and rebuke those who are opposing the will and work of God. As mentioned, the prophets did it routinely. So did Jesus. So did the disciples. And so often these were very public rebukes and confrontations. Yet many Christians find this far too off-putting.

Well, I prefer to run with how these biblical folks operated, instead of how so many modern believers do. "Open rebuke is better than secret love" we are told in Proverbs 27:5. And the biblical principle is this: private sin should usually result in private rebuke, while public sin should usually result in public rebuke.

Given that false teaching is almost always public (and just think of all the bad theology and false doctrine flooding the internet nowadays), that means that there will often be the need for public correction. See more on this here: billmuehlenberg. com/2013/08/16/on-public-rebuke/

But another verse I read after posting my response to this fellow especially stood out to me. Titus 1:10-14 says this:

For there are many who are insubordinate, empty talkers and deceivers, especially those of the circumcision party. They must be silenced, since they are upsetting whole families by teaching for shameful gain what they ought not to teach. One of the Cretans, a prophet of their own, said, "Cretans are always liars, evil beasts, lazy gluttons." This testimony is true. Therefore rebuke them sharply, that they may be sound in the faith, not devoting themselves to Jewish myths and the commands of people who turn away from the truth.

Hmm, this is yet another case of a very 'forceful' response by a Christian – the sort of response my critic thought was quite inappropriate for any believer. For some it seems that not only was Jesus quite wrong in how he went about doing things, but the Apostle Paul as well.

Let me offer a few quick remarks about this passage. Doriani and Phillips remind us of how important the matter of truth and error is:

We may see Satan's strategies against the church in two main directions. We most often think of persecution from outside the church, both from the surrounding culture and from anti-Christian governments. The New Testament often remarks on this threat and warns of our need to show courage in the face of suffering. But

the other attack arises from within the church in the form of false teaching. This is an even more deadly threat to God's people. For while persecution has the tendency to strengthen believers and even increase the size of the church, doctrinal corruption leaves Christ's people weak, scattered, and confused. If Christians ever have to choose between persecution and false teaching, the perspective of the bible encourages us to dread heresy above all other plagues.

And Hughes and Chapell offer this comment about the text in Titus:

Paul simply and stridently says about those carrying such a message, "They must be silenced" (v. 11). The word for "silenced" can also mean "controlled" or "Muzzled" and reflects the apostle's identification of his opponents as those who are not subject to control — i.e., "insubordinate" (v. 10). To modern sensibilities this

does not seem like a very tolerant attitude, but the reason for the apostle's imperative explains his zeal. He alerts us not only to what we should be concerned about (i.e., damaged doctrine) but also about who should be the focus of our concern.

As one meme making the rounds on the social media says, "If your entire theology is God is love and Do not judge then you don't have biblical Christianity, you have Oprah." Yep, time to get back to the Bible and leave the spirit of the age behind.

Afterword

As I have said so often elsewhere, we are indeed to speak the truth in love. And getting the biblical balance right is always crucial. As John Stott put it:

"This combination is rare in the contemporary church. Some leaders are great champions of the truth and anxious to fight for it, but display little love. Others are great advocates of love, but have no equal commitment to truth, as Jesus and his apostles had. Truth is hard if it is not softened by love, and love is soft if it is not strengthened by the truth."

I for one need to keep working on this. In fact, as I was writing this article I was also involved in some discussion on the social media. A Christian fellow started a rather unhelpful and unedifying thread under one of my posts. As we were going back and forth it suddenly disappeared.

I thought that was a good move of him to pull it, and I was going to tell him that and thank him in a private message. But then I discovered he did not remove it – he unfriended me, and blocked me to boot! Oh dear. So here is a word of advice: there is nothing virtuous or Christlike in being a grumpy old man (something he admitted to being). Instead it is a sin to be repented of.

There is a fine line between standing strong for truth and growing a thick skin in order to be a strong soldier, and just being a belligerent old grump. I know, since I am a grumpy old man as well, and God is dealing with me in this. I hope I am slowly learning to become a real ambassador for Christ in this regard. (As for this fellow all I can do is keep him in my prayers. Hmm, no wonder life was so peaceful during those six months in Fakebook Gulag!)

The Harvest Charge

Prime Minister Scott Morrison announced a

change to the words of The Australian National Anthem which came into effect January 1st 2021, the 120th Anniversary of Federation. We would no longer refer to Australia as "young and free", instead people sing "For we are one and free" - to reflect the country's long indigenous history. While the announcement came as a surprise to many, and the Prime Minister's authority to make the amendment was questioned, Rev. Fred welcomed the change for it's expression of a unified country.

What a timely declaration for our Nation to stand for being "one and free". From the trials stemming from public health orders of the last two years a new form of Unity is

In 1800, a seed offering was given to Australia by a farmer named John Churchill, to be planted for the "future benefit of our fellow-men, be they Countrymen, Europeans or Savages". In 1801

January 21.

Pray that we would not give up our birth right for a morsel of meat. That we would understand the times we are living in, and would hold fast to what God expects of His people when faced with temptation for the comforts of this world vs His kingdom.

January 22.

January 29.

Amazing Grace Turns 250!!

The Bible says: "And David the king came and sat before the LORD, and said, Who am I, O LORD God, and what is mine house, that thou hast brought me hitherto? 17 And yet this was a small thing in thine eyes, O God; for thou hast also spoken of thy servant's house for a great while to come, and hast regarded me according to the estate of a man of high degree, O LORD God.1 Chronicles 17:16-17

This year, AD 2022, Amazing Grace turns 250!

On December 31st, 1772, John Newton, a former slave trader, introduced the world to what we now know and love, as the grand old hymn 'Amazing Grace'. This awesome song still inspires billions around the world, 250 years after its lyrics were first constructed and chanted at his evangelical "low Anglican" parish church of Olney - a working class village in the county of Buckinghamshire, England, known for its Shrove Tuesday pancake race.

Originally entitled "Faith's Review and Expectation", the prayerfully chosen lyrics were carefully written for a New Year's Day service. After reading the above Biblical passage of 1 Chronicles 17:16-17 and reviewing his own life in the light of David's response, Newton reflected on how far he had come since his seafaring days of sinful lifestyle, self-indulgence and slave trading. The Vicar of Olney, like the King of Israel, was overwhelmed by God's amazing goodness and awesome greatness. It was right at this point, what would eventually become his best-known work was born.

Amazing Grace is now considered to be the most popular of our time. It is also the most recorded song in history. It is hummed and heard on every continent in this world. It transcends race, religion and even record categories. It takes in its stride all nations, regardless of colour, creed or culture. Whether presented in churches, performed in concerts or played in clubs, this Song of Songs touches many of the hearts of those who listen to its tune and learn its truth; this hymn of hymns transforms the souls of those who hear its message and heed its meaning.

This year, there's going to be a number of conferences and celebrations around the world. The 2-day conference that I'm looking forward to is the "Amazing Grace and its legacies: reflections at 250" co-hosted by "The Open University, The Cowper and Newton Museum and Olney Parish Church," UK. This year 2022 also marks:

- 1. The 274th anniversary of Newton's Conversion (March 21);
- 2. The 219th anniversary of Newton's last Will and

Testament (June 13);

- 3. The 264th anniversary of Newton's beginning to preach the Gospel (August 4);
- 4. The 236th anniversary of Newton's invitation to Rev. Richard Johnson to be the chaplain and missionary on the first fleet to the land Down Under (September 23);
- 5. The 215th anniversary of Newton's death. (December 21)

The Apostle of grace -Paul, puts it this way, and The Bible says: "But by the grace of God I am what I am, and His grace which was bestowed upon me was not in vain; but I labored more abundantly than they all — yet not I, but the grace of God which was with me."

25. Serving the NSW Parliament for 40 years

The 19th of September marked the 40 year anniversary of my career in Parliament as a Member of the Legislative Council.

I was elected to the NSW Legislative Council in 1981 and have been a constant champion for the natural family, human rights for the unborn, religious freedom, the dignity of women, measures to combat binge drinking, drug rehabilitation services, gambling advertising reform and much more.

I managed to achieve many legislative successes in that time including the Tobacco Advertising Prohibition Act which banned remaining forms of tobacco advertising in NSW. The Smoking Regulation Act which banned smoking in motor vehicles was also passed.

One of the most significant votes I cast was to secure the first Aboriginal land rights legislation passed more than 30 years ago, something the Indigenous people of NSW remember with gratitude.

Another significant achievement was the Parliament's support of my motion condemning the Armenian, Assyrian and Greek Genocide. And there are more reforms to come. Here is a list of legislation

that is either in draft or we are currently working on: Public Health Amendment (Vaccine Compensation) Bill 2021,

Children and Young Persons (Prohibition of Experimental Gender Reassignment Treatment) Amendment Bill 2021, Sex Selection Abortion Prohibition Bill and the Fairness in Women's Sports Bill.

My long service has only be made possible through the support of God and the people of NSW.

26. Unity in the NSW Legislative Council

The NSW Legislative Council has not formally met since June 24, 2021 due to the State Government's refusal to send at least one constitutionally required Minister or Parliamentary Secretary. The State Government has committed to a return on October 12, 2021, however this announcement is after months of broken assurances. I feel, this return is far from guaranteed.

In a rare but welcome display of unity, all non-Government Parties in the NSW Legislative Council have signed a cross-Party petition entitled 'Restore Our Democracy'. The petition calls on the State Government to send their Ministers back to Parliament so essential Parliamentary business can resume.

This petition is addressed to the NSW Attorney General Hon Mark Speakman and the Governor of NSW Honourable Margaret Beazley AC QC. The Governor of NSW has many roles but of relevance to this petition:

- Determining dates of Parliamentary sessions and elections
- Normally acts on the advice of Government but constitutional conventions do allow the Governor to take independent acts under some circumstances.

27. CDP congratulations Perrottet elected as NSW Premier

Following the resignation of the 45th Premier of NSW Hon

Gladys Berejiklian, it is heartening to see the appointment of Hon Dominic Perrottet as the newly elected Premier of NSW.

At 39 years of age, Perrottet is the Liberal Member for Epping and has served our State as Treasurer for over four years. He is happily married, the proud father of six children, a practicing Catholic and a faithful follower of our Lord Jesus Christ.





28. ICAC investigation intensifies – NSW Premier Resigns

In a bombshell announcement today the 45th Premier of NSW Hon Gladys Berejiklian MP has announced her resignation as Premier and as Member for Willoughby. The later resignation will trigger a by-election for the seat of Willoughby.

The Premier has dedicated her life to public service and her resignation would be a tremendous personal challenge for her. However, I feel the Premier has made the right call by resigning in the face of an intensifying ICAC investigation into her conduct as Premier.

We pray for Ms Berejiklian in her life beyond politics and wish her well.

29. State Governments keeps its word. Thousands of health workers lose their jobs.

The NSW Health Minister Hon Brad Hazzard has previously advised that all those working in the public health system are required to vaccinate before September 30, 2021 or face termination of their employment. Unfortunately Hazzard has kept true to his word and

thousands of hardworking and passionate health workers have been terminated as of yesterday.

Since 1977 it has been our Party Policy that responsible Australian adults have the right to choose their own form of medical treatment. I am confident that health workers have a well-informed knowledge and understanding of Covid-19 vaccinations and their informed right to vaccinate or not should be respected rather than scorned.

Hazzard stated yesterday "there won't be a position available for them (unvaccinated health workers) in New South Wales. So it's pretty simple – if you don't care enough to get vaccinated and look after your colleagues, if you don't care enough to look after your patients, then you probably shouldn't be in the health system." The Health Services Union Secretary Gerard Hayes said "There could be sort of 3,000-5,000 people who are not vaccinated. That will put pressure on the system. That's across, I think, all of NSW. And, any loss of any health worker will put pressure on the system".

The loss of thousands of experienced and passionate health workers across New South Wales will result in longer wait times in hospitals, understaffing across the sector, anxiety among their co-workers due to increased pressure and sadly avoidable deaths in hospital.

I call on the NSW Health Minister to reverse this terrible decision and respect the health workers who give their lives to saving others.

30. Power of prayer and police Cleo Smith found alive and well

Hallahriaht

In truly stunning news missing four year old Cleo Smith has been found in a locked house at 1 am this morning by police in Carnavon. To her parent's relief Cleo is both alive and well.

Young Cleo was first reported missing by her parents at Blowholes Campground near Carnarvon Western Australia over three weeks ago. An extensive search was conducted by local and federal police across multiple jurisdictions.

Christians across Australia have prayed for Cleo's return. The St Mary's Star of the Sea Catholic Church in Carnavon held a prayer vigil for Cleo's safe return, their prayers and that of all Australians have been answered.

Early police reports have announced that a man has been charged with Cleo's abduction. We pray that justice is served and that Cleo and her family are able to prayerfully enjoy the upcoming Christmas holidays.

31. A Digital Identity 'Card'

Australians have long been sceptical of vast government overreach and highly value their privacy. There should be no surprise then that there is great and growing opposition to the quietly proposed Digital Identity.

In 1985 former Prime Minister Bob Hawke introduced the idea of a national identity card called the 'Australia Card'. The Australia Card would have amalgamated almost all Government identification documents with the stated goal of reducing tax avoidance and fraud. The Australian people, the Federal Opposition and even Bob Hawke's colleagues baulked at the idea due to privacy concerns and the proposal was abandoned in 1987.

Identity fraud is an increasing problem in the 21st century but an online database is not a sure-proof way to stop it.

At the Evanta 2016 New York CISO Summit the former Deputy Director of the NSA Chris Inglis said 'there is no such thing as a secure IT system'. Our Government can take all reasonable steps to protect the personal information of Australians but by centralising our data you are inevitably inviting greater risk. As recently as April 2020 Service NSW was hacked through a series of phishing attacks, 5 million documents were accessed with the sensitive data of 104 000 Australians being stolen.

The draft legislation requires businesses to comply with the Digital Identity system. This will inevitably lead to higher compliance costs. Worse, it is business that is held liable for security breaches alone. There is no redress or compensation for victims outside of taking legal action against the entity that itself was the target of cyber-crime.

If the Government is serious about implementing a Digital Identity then perhaps it should take advice from comedian Rob Sitch's TV Series Utopia. Sitch's character Tony Woodford (who opposes a Digital Identity) cleverly suggests that such a scheme could be given a trial in Canberra and that all expenses, diaries and other affairs of MPs and public servants could be recorded to the System permanently. The Digital Identity is then abandoned!

Citizens' Legislation Action

The Parliamentary Calendar has now closed and Christmas is upon us. The last week of Parliament saw the successful passing of Voluntary Assisted Dying in the Legislative Assembly by a significant margin. When this dangerous Bill comes before the Legislative Council we fight it tooth and nail. The Member for Riverstone Kevin Conolly and others proposed 160 amendments to fix gaps in the Bill which were all rudely rejected by Member for Sydney Alex Greenwich. Rev Nile introduced a Bill that would ban the very real reality of Sex-Selective Abortion in New South Wales. Gendercide must have no place in our State. After many long years of campaigning Zoe's Law has been passed, the Bill (known as the Loss of Foetus Bill 2021) recognises the death of an unborn child as a result of motor vehicle crime by strengthening the minimum sentence, awarding funeral costs from the perpetrator, the unborn child's name to appear on a death certificate and victim impact statements to read in court. 32. First week back in Parliament after lockdown

On Tuesday 12th October the NSW Parliament returned to business and your elected representatives are now able to perform the vital democratic role that is demanded of them.

I was invited by the President of the Legislative Council to say the Opening Prayers and Welcome to Country. I was formally congratulated for my 40 years serving in the Legislative Council.

On Wednesday Hon Walt Secord MLC has moved a Bill to ban the use of the Nazi Swastika. My response was "I



am very pleased to support this Bill, the horrors of Adolf Hitler's Nazi Regime must never be repeated. Neo-Nazis and their evil symbology must not be allowed to propagate. I support this Bill without reservation". In the Legislative Assembly, Member for Sydney Alex Greenwich introduced a Voluntary Assisted Dying (Euthanasia) Bill. This radical pro-death bill must be defeated. If this Bill is introduced to the Legislative Council it will be fiercely resisted.

On Thursday morning I spoke on the lengthy suspension of Parliament and said "The Government had gone on strike ... and were preventing the House from conducting its business.. the Legislative Council was prevented from doing its job". I condemned the actions of the Government in shutting down Parliament for so long and said "I hope we will never see it (the shut-down) again".

33. Rev. Fred Nile supports NSW Teachers – Stands opposed to mass sackings

From November 8 all teachers and support staff will be required to be double vaccinated or face termination.

As those familiar with school life would know November is a very busy and important time of year for both staff and student alike. Exams are taking place, reports are being compiled and end of year preparations are occurring. It is reported up to five thousand teaching staff across New South Wales will lose their jobs on Monday unless the Government changes course.

Poorer educational outcomes are inevitable if hardworking and passionate teachers are ripped out of the classroom and out of a job. Leaving aside the economic and mental strife of the teachers themselves it is the students that ultimately suffer.

I wrote to the Premier, the Education Minister and the Health Minister and employing them to change direction. The CDP also garnered thousands of signatures in our petition to save teachers in New South Wales which was send to the State Government.

34. Week in review NSW Modern Slavery ACT, Sex-Selective Abortion Ban ICAC Support, Zoe's Law Legislated at last

The week commencing 15th November was tremendously significant week in Parliament for the Christian Democratic Party. I thank our Lord for what we have accomplished.

I am very pleased to say that New South Wales has finally passed a Modern Slavery Act with a commencement date of January 1, 2022. This comes after the original Bill was shelved by the State Government, despite both Houses voting for it in 2018. You can read my speech about this weird and unwarranted delay on page 44 of Hansard. We have worked closely with the Government, Opposition, Crossbench and the International Justice Mission to get this humanitarian legislation through.

On Wednesday 17th November I was proud to have introduced the Abortion Law Reform (Sex Selection Prohibition) Amendment Bill 2021 that would ban sex-selective abortion in New South Wales. This is not the first time such legislation has come before Parliament. In 2019 the Hon Damien Tudehope raised a similar bill. Then it was my privilege

to support Tudehope's Bill, I expect him and the Government to do the same now, especially with a Premier who is of the Catholic faith.

I have long supported Independent Commission Against Corruption (ICAC). The revelations exposed in the most recent sessions of ICAC only further the obvious need for a such a body, for the sake of public accountability, transparency and justice. To this effect, I have supported the ICAC and Other Independent Commissions Legislation Amendment (Independent Funding) Bill 2021 (No. 2). This Bill further facilities the operations of ICAC, this Bill passed with Opposition and Crossbench support, the Government voting against.

After a decade of lobbying Zoe's Law has finally passed both Houses of NSW Parliament. You can read more about the final version of the Bill and read the speeches by myself https://bit.ly/3HSwu9I, the Government and others here. Justice for the unborn, who have been the victims of crime is finally here at last.

DECEMBER

35. The Government's response to the Standing Committee on Social Issues Review of the Heritage Act 1977

I was pleased to see that the Government responded https://bit.ly/3GIL5Tw with support to the recommendations I made in the Standing Committee on Social Issues Review of the Heritage Act 1977 https://bit.ly/3ymHBmW .

The government indicated support in principle for The First Nations War Memorial Museum (Item 16 pg 6). The response states "The NSW Government supports the establishment of an Aboriginal War Memorial Museum subject to the preparation and outcome of a Final Business Case and consultation with Aboriginal communities."

We will continue working with the First Nations People's Advisory Committee and the Government till this project comes into fruition.

The other recommendations I made which was supported was for specific funding for Digitisation and Video Storytelling in Libraries, Museums and Galleries (Item 26 pgs 8-9) The NSW Government stated it "already allocates significant funding for the digitisation and video recording preservation of archives, records and artefacts in libraries, galleries and museums." Although a number of current digitisation projects were mentioned there was no mention of additional funds nor was there any mention of creating video storytelling using these records and artefacts.

We will continue working with Cr Linda Scott, President Local Government NSW to make sure all these recommendations are met. Cr Linda Scott had supplied evidence during the hearing and provided additional information to our supplementary questions to help us garner support in the committee for these recommendations.
